## PARISH COUNCIL REPORT

**Planning** – During the year we have been consulted on 50 planning applications (compared with 52 last year). These ranged from the usual tree works, retention of a panel fence, house extensions to several agricultural barn conversions. The council was very disappointed that the ESBC passed the application to remove the cedar tree behind Cedar Cottage, which we felt was a major contributor to the Conservation Area in the village centre. The Council has continuing concerns over the state of works on the Goats Head, which we feel can only be leading to a general deterioration of the fabric of the listed building and have had ongoing contact with the owners.

**Bromley Bulletin** – This year we published in June, November and February.

**Christmas Tree** – Finally it was decided that the small tree was big enough to carry the lights unaided and so it proved, however it was felt that next time we need a different power system and the Council is looking into reverting back to the mains supply. Letters have been sent in appreciation to the people who supplied the batteries and switched the lights on and off.

**Parish Council Surgeries** – Our regular bi-monthly Saturday morning surgeries (10.00am to 11.00am) in Church House have continued to provide access to Councillors. They have created a useful means of communication with the public.

**Best Kept Village Competition** – After the sterling efforts by Cllr Appleby and her teams of cleaners, clearers and litter pickers, Abbots Bromley came first in the East Staffordshire area Large Village category and also won the trophy for the Best Overall Village in the area. We are now looking to retaining the ‘crown’.

**Abbots Bromley Neighbourhood Plan** – Because of reasons beyond their control the Working Group was unable to submit the Plan to ESBC in November. I will leave it to Cllr Bryn Walters to give an update in more detail later.

**Highways and Parking** – After many years of trying the Council has been successful in obtaining a second sign at the junction of Lichfield Road and Radmore Lane and having the two signs for Miresbrook Lane replaced. We have had less success with the drainage problems and blocked gullies on Crown Bank but will keep trying. Pot holes have continued to be reported and most have been repaired although some have reappeared within a short time.

Parking on the main streets has continued to be a problem. Hopefully now the development work at the AB School and Ashbrook Lane has finished, fewer vehicles will be parked in those areas.

The Council has obtained additional ‘20 is plenty’ signs and a speed display unit. We wait to see how successful they will be.

There is a growing amount of correspondence with the SCC Highways Department over the narrowness of the pavement/footpath along Uttoxeter Road around the ‘airfield’, having started the work it was then postponed because of the state of the hedge and the weather, both of which are now improved but we are still waiting for the work party to return.

Like- wise we are still pursuing the SCC to remove the litter generated by the Ironman event, hopefully before the next one takes place on June 10<sup>th</sup>, they seem to be willing to laud the event as wonderful for the County but not so keen to clear up afterwards.

**Library Consultation** – Another consultation on the library service started on January 8<sup>th</sup> for twelve weeks. As the Staffordshire County Council needs to make savings the results are unlikely to be good for the rural mobile service.

**Mobile Post Office** – On a more optimistic note, a consultation has been run on the provision of a travelling Post Office van visiting the village to provide postal services and retail products, we await the results.

**Finance** – With the closure of the Youth Club and non-use of the grant the Council had allocated to them, we have been able to give grants to ABSA, Rainbows, Scouts and Richard Clarke First School at the end of the financial year.

**Jubilee Cup 2017/18** – Last year’s worthy recipient was Elizabeth Palmer for the many years involvement with the Abbots Bromley First Responders, both on the ‘front line’ and behind the scenes in the administration.

**Membership of the Council** – Having made a major contribution over the short time she was a member, Adele Wakefield left us and we welcomed David Denny on to the Council in January.

Financially the hall has suffered an operating loss of £3000 over the last 12 months due to a decline in use, however we do still have money in reserves to allow us to continue to

We are keeping on top of maintenance with various fixtures and fittings being replaced when necessary and we are currently under taking a review of our data protection and safeguarding procedures.

I would like to thank all the committee for their time and effort in keeping the hall up and running and hoping for a more financially prosperous next 12 months.

The last few months has seen a number of interested individuals who have started training and hope to join the community as responders as soon as training has been completed. (We have only one member from the village the other individuals all live towards Uttoxeter).

The life of the Abbots Bromley First response vehicle is a hard life, a lot is required from the ambulance and it is now starting to show its age. We may have another year or so before it will have to be replaced. Funds are being requested from a number of different sources and the paper work for this has been undertaken by myself.

The team will be three strong soon once new course personnel have completed their training and old CFR have passed refresher training.

I am feeling hopeful about the team's future, we still need support from our community and our MP in insuring that CFR training is completed by West Midlands Ambulance service.

We are still called on and job numbers are only slowed down by the amount of hours Abbots Bromley has responders on duty.

### **Richard Clarke First School Report**

Here is a brief summary of some key elements for the past 12 months.

**Financial:** The 2018-2019 budget is has now been set and, as usual, it will challenge our financial control capabilities. However, thanks to healthy pupil numbers and the expert attention of RCFS management, we believe that we will generate a small surplus this year. If so, it will enable us to replace some of the reserves that we had to use last year. Further ahead, the situation still presents risks and uncertainties to be overcome. We have an annual budget approaching £600,000 of which about 75% are staff costs. However, we will maintain the existing staffing structure which has delivered the high quality of education and pupil care of which RCFS is justly proud.

The DfE proposals to rebalance school funding across England are still in the pipe-line but will probably not be a life-changing event, although there are cross-party demands for a realistically generous response. Will additional funding be offered or will existing funding simply be re-allocated? The obvious problem is that all children have individual needs and each school presents a unique composite of these needs. To find a straightforward formula or algorithm with sufficient flexibility to satisfy the underfunding problem seems to be an impossible demand.

On a more positive note, we have a superb PTFA who continue to raise money for projects in RCFS. The current 'mission impossible', which we have asked them to accept, is to raise money to help towards the upgrade of our creaking ICT infrastructure. The Parish Council have also made donations and, of course, we have the Endowment Fund from our eponymous founder, to whom we regularly offer a prayer of thanks.

**Number of Pupils:** We are predicting 130 to 132 pupils for the Autumn Term 2018, the largest number for many years. This will give us a well-balanced number of pupils across all Year Groups which will, of course, generate more revenue from the funding formula. New housing developments in Abbots Bromley will have helped but out-of-catchment demand, attracted by our reputation, has also contributed to the healthy roll numbers.

**Staffing:** The staffing structure remains remarkably stable and has allowed us to have a full-time teacher in every class, with excellent classroom support from teaching assistants and, of course, parent helpers. Preserving this structure against the risk of unmanageable external financial pressures is one of our highest priorities. The RCFS staff has an excellent range of teaching and learning skills which are shared across the school by an in-house mentoring programme.

**School Performance:** Most previous reports have mentioned the possibility of a snap OfSTED inspection. However, since this took place in January 2017 (see last year's RCFS Report) we have been able to relax just a little and enjoy the initial warm glow which comes from having our excellent qualities recognised. We then, of course, have to continue with our role in providing the education that our children deserve. Our key priorities for 2018 are:-

- To continue to develop and improve the quality of teaching and learning in maths
- To evaluate and improve standards of phonics and spelling across the school
- To raise the profile of health and well-being of pupils and staff
- To bring our data protection practises in-line with the new GDPR regulations

The above are specific, headline priorities which have to be addressed but the on-going priorities, which define why we exist, have been absorbed into the fabric of the RCFS experience - Pupils' *Mastery* across the curriculum, Early Years Teaching and Learning, Safeguarding, Developing the Learning Environment.

**Uttoxeter Learning Trust (ULT):** There are 17 schools in the Uttoxeter Pyramid and 7 have currently opted to join the ULT and 4 have decided to join the Staffordshire University MAT. One school is changing to a full primary (adding Years 5 & 6) and 5 schools, including RCFS, are choosing to remain as maintained schools. Our decision to stay with LA support is based on our assessment that RCFS performance, governance, financial management and leadership do not require the improvements that proponents of academies claim would be delivered. Financial pressures could, be a major influence on

our decision in future but, for the moment, we firmly believe that the benefits to our children are better served by staying as an LA maintained school.

**Summary:** RCFS has maintained its excellent reputation for leadership, classroom skills, financial management and governance and it will continue to use these qualities to address future pressures which, as most people acknowledge, are never very far away in our education system. We have continued to give our children an excellent learning experience which will prepare them well for their onward journey to maturity. RCFS is regarded very highly by its current parent cohort and by other parents across the region. Most schools across the country have to face funding challenges; some believe that joining a MAT is their only solution. We believe that we are in a better position than most to deal with the challenges, although it will not be easy. I wish to offer my thanks to the RCFS leadership and the classroom staff who continue to deliver excellence despite having to contend with a changing curriculum, moving goal-posts and the latest educational fads; to the parents who support and encourage them; to the governors whose skilled and dedicated efforts are crucial; and of course to the children who respond brilliantly to all of the above.

**Uttoxeter Rural Division Annual Report April 2018**

I continue as the Leader of the County Council with other roles on the council's behalf such as the Local Government Pension Scheme, Stoke and Staffordshire Local Enterprise Board, Midlands Engine Strategic Board and Midlands Connects. I am Vice Chairman of the County Council Network and am a Member of the Local Government Association Resources Board and the Cabinet Office's National Growth Board. A busy life as I still farm at Abbey Fields in Rocester, on South Staffordshire College Board and Rocester Parish Council.

We have had two by elections over the past year because of the death of two county councillors, both of them fit, active and sporty individuals in their Fifties. The Conservatives retain overall control of Staffordshire County Council with 51 seats: Conservative 51, Labour 10 and Other 1.

The past year has been one of the most difficult I have known as a county councillor. Councillors and officers have been hard at work on the budget and in February we approved several important pieces of work including our four-year strategic plan, our budget for 2018/19, and an additional £5 million investment in fixing potholes. However for this financial year we will see the County Council delivering record spending on care of the most vulnerable in our communities and still balance the books. This is a huge achievement at a time when financial pressures remain immensely challenging.



And, as we move to becoming self-financing, due to the loss of Government grants, it's become increasingly important that we continue to grow our economy and support the creation of a more skilled workforce. This coupled with promoting the development of housing needs will help make the council even more self-sufficient.

Some of the headlines from the four-year plan and budget include:

- Investing a record £310 million this year on care of the elderly, people with learning disabilities, and children in our care
- Remaining the third lowest county council tax despite raising it by 5.95 per cent this year, which includes the Government's 3 per cent ring-fenced precept to be spent on social care – equivalent to an overall rise of around £1.30 per week in county council tax on a Band D property
- Spending an extra £5 million once again to tackle potholes in 2018/19
- Bidding to be part of the Government's next round of business rates pilot, which could bring in an extra £10 million to the county council
- Rolling out the Smart Staffordshire programme – maximising the use of digital technology to benefit residents and businesses
- Encouraging a programme of housing development to support growth and investment in the county.

Over the past eight years we have achieved a huge amount in transforming Staffordshire for the benefit of all its residents. More people are in work, young people are leaving school and college with better qualifications, people are living longer, and tell us they feel safer and happier than ever before.

While we are proud of these achievements, the world around us is changing fast and there is so much more we want to do. We will continue to work with our local communities and all our partners to make sure we give the people we serve every opportunity to improve their lives.

In recent years the county council has been increasingly honest that we can no longer afford all the things we used to do or would like to do. We need to find different ways of working that help people to help themselves, take greater personal responsibility for their own lives, health and wellbeing, and greater responsibility for improving their own communities.

The county council will receive no funding from government and become self-funding by 2020 and on top of demographic pressures of social care we will have to save £37M next year. But we have started to work on this early so we can plan early. In the next part I will try to map out changes that lie ahead with something we call "Plan on a Page". The county council cannot do this alone; but must continue to work with all parts of the public and private sector and our residents themselves.

### The Staffordshire Economy

We all agree and understand that people in gainful employment are healthier, safer and less crime is committed, reducing pressures on vital public services.

The latest March unemployment figures have been released and show our number one priority of having a productive Staffordshire economy is working.

In Staffordshire there are 6,795 people claiming out of work Universal Credit benefits including Job Seekers Allowance, this equates to a rate of 1.3%. The number and rate of claimants has increased by 295 compared to the previous month.

Under Universal Credit a broader span of claimants are required to look for work than under Jobseeker's Allowance. As Universal Credit Full Service is rolled out in particular areas, the number of people recorded as being on the Claimant Count is therefore likely to rise.

Staffordshire County has the second lowest rate in this measure of all West Midlands Strategic Authorities. In England the rate is 2.1% and for all of the West Midlands 2.7%. With so many employed and such a small number of people claiming benefits across Staffordshire, this is good news for everyone in the county and means people are making the most of the opportunities on offer and our long term economic plan in action.

### **Our economy plans for 2018 and beyond build on past successes**

Look around Staffordshire and you'll see new business premises and enterprise parks occupied by global companies, inventors, entrepreneurs, and local creative companies. This is all part of our plan to grow our economy and create opportunities for people to fulfil their aspirations of a better life by generating more "better" paid jobs.

The importance of a strong and growing economy cannot be underestimated. Ensuring people are in work and have money in their pocket to lead the lives they want remains the most important thing we can do to improve family incomes and reduce demand on public services. We will do this by creating the right conditions for businesses to grow and thrive.

2017 saw yet another successful year with not only the further development of new business sites such as i54 South Staffordshire, and Redhill Business Park, but vital improvements to infrastructure like roads and superfast broadband now available at 95 per cent of premises. Our economy is in good shape. Business Parks in Staffordshire are now home to leading international businesses such as Jaguar Land Rover, Gestamp and General Electric which inject millions into the local supply chain. But smaller local companies, which account for 96 per cent of all businesses, also play their part too, reinforcing their role in the local economy.

Since 2014, economy boosting projects with a total value of £383 million have been completed, are under construction or being planned. This should result in the creation of some 13,000 jobs for local people. In line with this, we've also seen near full employment over the same period, with just one per cent of the local population claiming unemployment benefits. This is lower than both regional and national averages.

A high number of our schools are rated as good and last year our skills programme created more than 5,000 apprentices and supported three new Advanced Manufacturing and Engineering Skills Hubs. Teams also started visiting schools and talking to pupils to raise aspirations about the higher skilled jobs of the future.

With even more exciting projects like the Smart Innovation Hub at Keele University Science and Innovation Park coming online soon, and the completion of the A50 Project A improvements in Uttoxeter at the end of 2018, we are looking forward to building on these successes.

We're opening doors for business to grow. We're attracting new investment to the county and we are making Staffordshire right for business to improve the lives of everyone living here.

### **New Uttoxeter Household Waste Recycling Centre**

The new £1.5 million household waste recycling centre in Uttoxeter is now operational on brownfield land off Dove Way, to replace the town's previous permanent site at Pennycroft Lane. It's a really modern facility that offers everything people need to recycle and it will be easily accessible for residents from the town and the surrounding area. Like all our centres, the site will accept the usual wide range of recyclable household waste, including cardboard, cooking oil, garden waste and electrical appliances. It will be open five days a week, closing Wednesdays and Thursdays.

It is a statutory duty for the sites to accept household waste for free, this is waste produced in the normal day-to-day occupation of a home. Additional waste such as landscaping or construction work is considered as non-household waste and we do not have to accept this waste

As a result, SCC will charge for the disposal of some non-household waste which includes soil and rubble, plasterboard and tyres at our recycling centres. The charge will contribute to overheads and the cost of disposing of the materials.

Charging will ensure that we can continue to offer disposal facilities for these materials to residents, who would otherwise find them difficult to get rid of and will ensure that the system is not abused by those seeking to dispose of trade waste for free.

### **A50 Growth Corridor update: April 2018**

Despite the recent poor weather, we remain on schedule to complete the work later this year. Surfacing of the new slip roads and three roundabouts has been completed recently and the next main piece of work will take place in June. This is when we will integrate the new slip roads on and off the A50 into the existing dual carriageway. To do this as safely and quickly as possible, while keeping inconvenience to the public to a minimum, there will be a series of overnight closures between the B5030 roundabout at Uttoxeter and the A521 roundabout at Blythe Bridge:

**Wednesday, 13 June from 8.00 p.m. to 5.30 a.m.**

**Westbound carriageway closed. Eastbound carriageway open as usual.**

**Thursday, 14 June from 8.00 p.m. to 5.30 a.m.**

**Eastbound carriageway closed. Westbound carriageway open as usual.**

**Friday, 15 June from 8.00 p.m. to 5.30 a.m.**

The closures have been scheduled so that on Thursday, June 14 traffic heading towards Stoke-on-Trent will be able to get away from the popular Ladies' Night event at Uttoxeter racecourse without any difficulty. The dates of this work may change due to weather conditions and we will notify you if that is necessary. During the closures, we will put a fully signed diversion route in place, suitable for all vehicles, including HGVs. Highways England will put advance notices warning of the closures on its wider A-road and motorway network to encourage traffic to take alternative routes on the nights of the closures.

Traffic heading east will be diverted northwards from the A50 on to the B5030 for a few hundred yards to the roundabout with the A518. Traffic will turn right there, cross back over the A50 along Dove Way and continue on the A518 clockwise around Uttoxeter and follow the road towards Stafford. Vehicles will then follow the A51 and A34 towards Stoke-on-Trent and then on to the A500. The route is reversed from the west. The Shell petrol station, which stands on the westbound carriageway a few hundred yards west of the B5030 roundabout, will remain open as normal and access will be maintained via the A522.

The A50 is the most important transport link between the East and West Midlands. The planned improvements will also benefit major employers and their employees between Stoke-on-Trent and Derbyshire, making journeys quicker, easier and safer. Staffordshire County Council is delivering these improvements on behalf of Highways England.

**Project B** is located to the East of Project A. Highways England is currently considering how to take this project forward.

### **Highways Defect reporting**

The highways call centre will no longer be accepting emails as a way of **reporting defects**. They are encouraging the public to use the new reporting systems in place as well as the 0300 111 8000 number.

### **Other Highlights for 2017:**

74.5 per cent of Staffordshire pupils achieved a Good Level of Development at the Early Years Foundation Stage. There was an improvement compared with 2016 (73.8 per cent) and results were again ranked within the top quartile nationally. Staffordshire had the highest proportion of pupils achieving a Good Level of Development out of all of its statistical neighbours; a pattern also evident in 2015 and 2016.

The number of delayed transfers of care in Staffordshire that were attributable wholly or jointly to social care in November 2017 was higher than the national average. Staffordshire had 1,452 delayed days (a rate of 239 delayed days per month per 100,000 populations compared to the England average of 145 delayed days per 100,000 populations). However, this was the third consecutive month that recorded a reduction in social care delays, which peaked at 277 days per month per 100,000 in August. The latest position is in line with the Better Care Fund target trajectory agreed with NHS England.

In December 2017, there were 1,092 looked after children in Staffordshire which is a rate of 65 children per 10,000 population. Recent information released by the Department for Education has shown an increase nationally in the number of looked after children and this increase has also been seen in both Staffordshire's statistical neighbour comparator group and across the West Midlands as a whole. In December 2017, 8.0 per cent (87) of looked after children were Unaccompanied Asylum-Seeking Children (UASC), compared to 8.9 per cent (89) in December 2016.

In December 2017, the rate of recorded crime reduced to 4.1 crimes per 1,000 population and the rate of reported anti-social behaviour incidents remained stable with 2.0 incidents per 1,000 population.

### **Education School places**

Nine out of 10 parents in Staffordshire have been offered their first choice primary school, despite rises in pupil numbers putting pressure on school places with the majority of parents allocated their first choice school, with 98 per cent in total allocated one of their top three preferred schools.

A total of 9,278 places have been allocated, with 8,565 of those receiving their first choice primary school and 9,110 getting one of their top three. This is despite a rise in birth rate of up to 11 per cent in Staffordshire over the past decade putting more pressure on



school places. Parents have an automatic right of appeal for a school of their choice even where they have been allocated their second or third choices. Key contact numbers are:

Established in 2015, the event quickly grew to become the biggest IRONMAN 70.3 race in the UK. After three years, the event has seen nearly 8000 athletes competing, also attracting some of the UK and the world's best professional athletes. It also became the fastest selling IRONMAN 70.3 race in the UK selling out within minutes in 2015.

Since it was announced earlier this year that the 2017 edition would be the last to finish at Shugborough Estate, anticipation for the new venue announcement has been high. From 2018 onwards Stafford Town Centre will be the host venue for the athlete village, expo, second transition area, run course and finish line, bringing the festive race atmosphere right into the heart of the town.

Logistically, this makes it easier for athletes, their supporters and spectators to make their way to the athlete village as well as allowing supporters to get closer to the race than ever before.

The move will also see a change to the run course with the second transition area located at Riverway and the run course consisting of three laps in and around the town centre, finishing in Market Square. The bike course for the most part retains all the elements that have made it an attraction over the last three years with the exception of some improvements. The swim will remain at Chasewater Country Park..

## **Getting the Best Deal for Staffordshire from HS2**

Your county council remains totally committed to getting the best deal for Staffordshire from HS2. This extends to getting the best deal for the county in terms of mitigation, compensation for residents, economic benefits and improved connectivity.

To achieve this, we have petitioned against Phase 1 and successfully achieved the lowering of eight km of the line in Lichfield. Staffordshire County Council also secured an assurance that the Handsacre link, connecting HS2 to the West Coast Main Line, would be constructed. This will provide the infrastructure needed for Staffordshire to receive HS2 services and gain economic benefit as a result.

When the Phase 2a hybrid Bill was deposited to Parliament in July last year, along with the associated Environmental Statement (ES), the ES was subject to a 10 week consultation. The county council submitted a joint response with Lichfield District Council, Stafford Borough Council, and Newcastle-under-Lyme Borough Council. This response will form the basis of our petition to the House of Commons and we appeared before the Select Committee in April, giving evidence.



We have also been meeting regularly with HS2 Ltd to discuss pressing issues (construction routes in particular) to try and progress agreements to give us the best chance of reaching agreement prior to a select committee appearance.

To further support our residents, each County Councillor whose division is affected by HS2 has been allocated a small budget to help affected communities. Councillors can use this to, raise awareness, hire village halls/venues and produce mitigation documents, fund reasonable transport costs to support participation in the Phase2a parliamentary process.

### **Superfast Staffordshire Website Shows When New Broadband Will Arrive**

Householders and businesses in East Staffordshire can find out exactly which areas will be getting faster internet speeds—the first communities already feeling the benefit. You can find when and where the faster fibre broadband will be available at the Superfast Staffordshire website [www.superfaststaffordshire.co.uk/](http://www.superfaststaffordshire.co.uk/)

Staffordshire County Council, BT and Broadband Delivery UK (BDUK) are working in partnership to deliver superfast broadband services across Staffordshire as part of the national programme managed by BDUK. When added to the commercial roll-out we now have 95% of premises receiving speeds in excess of 24 Mbps.

Unfortunately there was insufficient funding available to achieve 100 per cent coverage, which means that additional funding and further developments in technology will be required to address the remaining 26,000 premises (final 5 per cent). I am well aware that this affects Uttoxeter Rural.

Recently BT has made £2.4 million “gain-share” funding available to Superfast Staffordshire to reinvest in extending the network further. This will be used to start and reduce the number of premises in the final 5 per cent. This reinvestment is taking place much earlier than anticipated, as the demand for superfast broadband services has been greater than originally predicted.

## A515 and HCVs

With economic growth comes traffic and the issue of Heavy Commercial Vehicles (HCVs) and there have been extensive discussions to find a solution to issues around HCVs using the A515 as a shortcut from the A50 to the A38.

This is not proving as easy as it sounds, as alongside powers come duties. The trunk road network, including the A50 and the A38, carries the majority of HCVs through Staffordshire. However the A515 also forms part of the country's Network and provides an important sub regional route that facilitates the direct and efficient movement of people, goods and services; contributing to the economic prosperity of the area.

The county council has a range of powers and duties as the Local Highway Authority including the power to prohibit or restrict HCVs from using certain routes and the power to reclassify a route; but this sits alongside a duty to secure the movement of traffic ensuring efficient use of the network.

The Traffic Management Act 2004 places a duty on the county council to ensure traffic can move quickly and freely on its own highway network and that of nearby local highway authorities. The county council and Highways Agency has agreed emergency diversion routes in place along the A515 in the event of a closure on the A38. It is not possible to divert non-motorway traffic onto the higher class motorway network during such a closure. The A515 is also a national priority route for high sided vehicles.

Proactive re-directing of HCV traffic from the A515 would be difficult to enforce and could ultimately lead to a concentration of HCV flows in other localities, making the situation even worse for those affected communities.

The County Council has commissioned a traffic survey which recorded speed, volume and routing of traffic on the A515/A513. Footage from CCTV cameras installed by the Council will also be used. From that data one potential solution is a temporary HCV weight limit on the A517 at Kings Bromley, which accounts for 70% of the HCV traffic, and see whether this could be made permanent. This is now following due process.

I have continued to press for additional deterrents on top of the traffic lights on Dove Bridge and the speed cameras in Draycott. These measures are in the form of the average speed cameras on the A515, village gateways and better access from the A38 to Fradley. The aim is to deter HCVs by hindrance and delay from using the A515 while improving their passage on the A50 and A38.

The Staffordshire Freight Forum was formulated following a recommendation of the Prosperous Staffordshire Select Committee Report

An outcome from the last Staffordshire Freight and Communities Forum was for the creation of an A515 working group to discuss issues at a local level, leaving the Freight Forum to operate at a strategic level across Staffordshire.

**1. Chairman's Welcome and Report.**

Cllr P Charles presented the Chair's report (see full report earlier the document).

A resident asked about the 30mph signs on the Lichfield Road, would it be possible to have more reminders of the new speed on the way out of the village. Another resident asked if it would be possible for a narrowing of the road to be considered to help reduce speed.

**2. Presentation of the Certificate for last year's winner of the Jubilee Cup**

Cllr P Charles presented the certificate to last year's winner of the cup, Mrs Elizabeth Palmer.

**3. Presentation of the Jubilee Cup**

Cllr P Charles then presented the Jubilee Cup to Mr Richard Hall. He thanked Mr Hall for providing the walk to the reservoir via his land. This is greatly appreciated by the village. Mr Hall said that he was very pleased to receive the cup and surprised how much the walk is being used.

**4. Grant Cheque Presentations**

Cllr Charles presented grant cheques to village organisations. The following organisations received grants: Abbots Bromley Scouts £250.00 for repair and maintenance of camping equipment; Abbots Bromley Rainbows £250.00 for purchase of aprons and high visibility jackets; Richard Clarke First School £250 towards the outdoor classroom and Abbots Bromley Sports Association £500.00 towards the sports facilities. Each organisation collected the cheques and thanked the Parish Council and provided updates on what the money would be spent on.

**5. Abbots Bromley United Charities**

Cllr Charles presented the accounts for the United Charities. He confirmed that 40 parishioners had received donations. Donations also received by The Friendship Group, Evergreens, Abbots Bromley Scouts and Guides and Abbots Bromley Sports Association.

**6. Parish Council Accounts**

The Unaudited Parish Council Accounts were made available at the meeting.

**7. Report from Borough Cllr Hall**

Cllr Hall reported that ESBC has not increased council tax this year. A grant of £20,000 had been provided for ABSA for second phase on top of the £10,000 for first phase. Congratulated ABSA on the work they had done so far, way ahead of any other sports grounds projects in the area. East Staff Local Plan adopted in 2015, 6 years of preparation. Since this there has been a large drop off of applications for developments outside of the plan, however, not that simple. If the five year land supply drops then it becomes a 'free for all'. Applications may be positively considered if this drops. 17 neighbourhood plans now in Staffordshire and some have been made for some time. Some have been very successful and other not so much. He confirmed that he is pleased to support the Neighbourhood Development Plan Group in Abbots Bromley. Thanked everyone for their time.

Cllr Charles said that before starting on the Neighbourhood Plan he would like to mention Community Speed Watch. So far one person has volunteered but if anyone else would like to come forward please pass on details to Sarah Meads, the Clerk.

**8. Abbots Bromley Neighbourhood Plan Update – Cllr Bryn Walters**

The group is bringing the draft plan together. Everyone will have a chance to comment on it. There will be 6-8 weeks of consultation. Nothing has been decided and set down at this point. Needs community comments and has to go through a referendum. The group are trying to put in as much information as possible. Everyone that votes in an election will get their chance to have their say. There has been a lot of background research. The draft needs to include the maximum amount of information. 17 parishes completed their neighbourhood plans and it has been useful for Abbots Bromley to learn from what others have done.

The process has taken time and we have lost two members, timing has slipped and the timescale will be undated. Cllr Walters thanked those that had to stand down. The Parish Council has asked for the timetable to be updated and this will be made available to everyone. The group eventually recruited two new members after much advertising in the village.

The site assessment feedback was provided over 12 months ago when Abbots Bromley School came to talk to the village at the meeting held in the Village Hall. The site where the cricket pitch is has become available as the cricket will be moving on to Lichfield Road.

The group is close with the draft now and working with the sites identified, making sure that all the information is available to the community. Could have brought forward the consultation earlier and not provided all of the information.

Member of the public commented; what you are saying is that nobody has any information as you haven't put any information out there. The only person who has put information out there is Mr Wheeldon.

Cllr Walters said he would run through all the information that has been put out.

October 2015 community meeting, consultation went out to the community. As part of the public meeting asked for volunteers to join the group and then a working group was formed.

Jan-March 2016, initial consultation, the group put a questionnaire through every single front door, to find out what people wanted in the village. This went to 750 homes.

A member of the public asked how many responses were received. Cllr Walters confirmed that 96 were returned giving a 13% return rate. Main concerns raised were housing, traffic and parking. Mr Wheeldon said 750 went through front doors, 250 displayed by buckets and 36 through conversations. 1036 pieces of paper, 96 back, so percentage 9.6%. Cllr Walters agreed that it was not great but better than other communities. Feedback session in the Village Hall, detailed issues raised. Decided to look at what the issue is with housing so did a housing needs assessment June – Oct 2016. Again this went through all doors and also via Horn Dance day stand. Housing needs questionnaire 145 returned. Cllr Walters confirmed that the results of survey are on the website.

Church House event, Dec 2016. Those that attended helped to weight importance of selection criteria for sites. What issues do we need to look at when assessing sites? eg heritage, transport etc. Community helped with this process along with East Staffs Borough Council. Issues were weighted by those that attended that event. Mr Wheeldon confirmed that twelve members of the public attended that event along with members of the group. Cllr Walters said that attendance wasn't great but the event was advertised widely including noticeboards, social media, the Bulletin and website.

Cllr Mrs Moore commented that there has been a lack of engagement so far but as so many people have turned up tonight then we need to harness this enthusiasm.

Cllr Walters confirmed that the group looked at potential sites, visiting sites individually and not as a group, collated results and two sites came out as preferred sites.

A member of the public asked how long the process took. Cllr Walters said that it took a few days. Member of the public said that the assessment is your assessment and not the village. Cllr Walters said that the community that attended the event at Church House identified the selection criteria and then the group used this to select the sites. Member of the public reiterated that the

sites were chosen by the group and not by the village. You never put those sites out to the village. Member of the public asked if the sites are published anywhere. Cllr Walters confirmed that sites are published on the noticeboard by the Buttercross and also on the website.

Cllr Walters said that he would stop there and asked for questions.

Comments from members of the public:-

- If the group is not engaging then we need to address why we are not, we tried, we didn't get there, step back and regroup in order to make better advance. Ground swell of serious engagement now. Approach the community differently. The member of the public volunteered to be part of the group in the future.
- Cllr Walters said that would be great, who wants to be join us on the group. The member of public confirmed he would come forward.
- Member of the public said Mr Wheeldon is very passionate about the village and many of us were surprised when he resigned from the committee. Would it be possible for Mr Wheeldon to say why he stood down from the committee? Cllr Walters said that Mr Wheeldon was very dignified when he stood down but Cllr Walters said that he didn't ask why he stood down. A member of the public said that this was put in a letter to Cllr Walters.
- Mr Wheeldon stood up and said that he resigned from the group as his moral obligations had been compromised. He said he had asked for reviewing, going back, regrouping which he asked for in front of committee members. He compromised his moral obligations once too often. This was in the letter. He said he also offered the committee the opportunity that I would re-engage with the group. He said that he does believe in the Neighbourhood Plan and knows that the Chair, Cllr Walters has a hard job and he respects that but he didn't listen to him. It would help if Cllr Walters listens to what he has to say later in the meeting. Mr Wheeldon said he is proud of those speaking up at the meeting. Cllr Walters said that we were very appreciative of the work you did on the group. He said that as the chair of the group he has tried to take the majority view. It is not an easy job and a thankless task. He does agree that it is important that we make choices. Nationally there is a house building problem, we need to try and mould it to what we want.
- Cllr Walters agrees that it is an important process and when there are other villages around us with neighbourhood plans this makes us vulnerable. He wants us to be able to have a say in what development comes forward
- A member of the public asks why we would be vulnerable compared to somewhere like Newborough? Cllr Walters said that the local plan says that a certain amount of houses need to be delivered in Staffordshire, this plan goes up to the 2030s. In terms of Abbots Bromley we are required to provide 40 houses across two sites. One site has already been built, the one down Lichfield Road. The other site is on Uttoxeter Road which hasn't come forward yet.
- Member of the public said that the 40 have already been met with infill sites and what you haven't done with your site selection process with mention the site that is sat waiting and vacant and could provide affordable homes or whatever. Your site selection process is flawed and doesn't meet the statutory requirements and you didn't put these sites for the community to vote on, you have put forward two sites in your draft plan and these are the ones that we vote yes or no on.
- Cllr Walters said that if the community comes forward and says that we don't like these sites, we don't like this process and clearly we will have to think again.

- Member of the public asked why some other sites weren't put in the draft plan. The site selection process is flawed, it has discriminatory factors in it which means one site is benefited over the other and in addition to that you didn't apply the selection criteria of suitability, availability and viability. Your own report doesn't give any details on the other 8 sites gives details on suitability, availability and viability.
- Cllr Walters said that we have taken advice from ESBC but it is not a perfect process. We have taken advice from other parishes and ESBC and we have tried to do the best we can.
- Member of the public said then the advice would be to do what the gentleman said earlier and take it back, do the site selection again and revisit it with the community.
- Cllr Walters said that we have to want it to make it work and we need more people.
- Borough Cllr Hall commented that he thinks that it's great that we are doing a neighbourhood plan. Plan needs to get to the next stage. He is happy to help. He believes that the process has been a fair and a good one. Cllr Hall says that it is good thing that so many people are at the meeting. He said that you could consult endlessly on what could go in a draft but someone still has to make the decision as to what goes in the draft. Easy to pick holes in something that someone else has done
- Member of the public says that you are putting in two sites so there is no choice.
- Member of the public says that the group isn't listening and should consult on more sites.
- Member of the public commented that everyone has to remember that all this work has been done by volunteers, they are not paid for it and they give up their own time and we should be very grateful for this. People don't come forward and volunteer to do things and don't fill in surveys. We should say thank you for what they have done.
- Cllr Hall commented that the village originally had an allocation of 200-300 homes but this was reduced to AB becoming a tier two village with an allocation of 40 homes which were generally market homes.
- A member of public asked how far down the line are you with talking to landowners and property developers on the two sites you are talking about.
- Cllr Walters confirmed that the group had spoken to Abbots Bromley School and the developers. Member of the public asked if there is a plan. Cllr Walters said that it will come through as part of the draft plan. He said that we are trying to bring forward the maximum amount of information we can otherwise people would say that we haven't provided the information.
- Member of the public asked if you have given all 8 sites the same opportunities so if you haven't done this, why not, seem to be railroaded in to two sites. He doesn't have a problem with two sites being considered but not happy with one site being more developed in terms of discussions. Does have a problem with one site being significantly more developed than the other. Greg as a District Councillor could have a conflict of interest as he may have to vote on it at some point. What he is concern about is it not being a level playing field.
- Cllr Walters said that Cllr Hall will have the same vote as a resident as anyone else. Acknowledged comments and explained that the sites had been chosen as a group. Draft plan for consultation we need to put in as much information as possible and if we hadn't spoken to the school then people would complain that there wasn't enough information. The plan needs to go to SCC Highways as well. Need to consult on the number of houses. Needs to ensure that the plan included the maximum amount of information.
- Member of the public asked if any work been done on traffic flow on the roads. Cllr Walters said that this work has to be done by Staffordshire County Council Highways as



they will be consultees. Member of public said how many houses are there going to be on the site, is it going to be 40.

- Member of the public said how many houses have you asked the school to provide on that site. Let everyone know what figures have you given to the school, you have written to the school and asked them for 30 affordable homes.
- Mr Wheeldon said that it was at this point you should have consulted. Additional member said that this is where the red line should have been drawn.
- Member of the public asked if there is any information on the website as to why the other sites were rejected. Cllr Walters confirmed that the information is on the website. Member of the public said that he had written to Cllr Walters to ask for the information but had not received it.
- Member of the public asked where would the access to the site be?
- Cllr Walters confirmed that this would be off Radmore Lane by the equestrian centre.
- Member of the public said that this is where the red line should be.
- Member of the public said that you should find these red lines earlier in the process.
- Member of the public asked if Mr Wheeldon could speak.

### **Comments by Mr T Wheeldon**

“As the Parish Council is the elected body with the formal power and responsibility for the production of the Abbots Bromley Parish Neighbourhood Plan .... I wish to direct my comments to the Parish Council Chairman”

Mr Chairman,

A Neighbourhood Plan gives communities direct power to develop a shared vision for their neighbourhood and to shape the development and growth of the local area.

In order to achieve this it is a statutory requirement that a robust and effective regular two way consultation and engagement process is undertaken with residents at every stage.

The process should be 100% community led, and a true reflection of a ‘proportionate’ and robust evidence base; ultimately leading to statutory community consultation and referendum.

Over recent months many residents from the main conurbation of Abbots Bromley and the wider Parish, have sought to engage me in conversation in relation to their understanding of the Neighbourhood Planning process.

The feedback that I received from these conversations stimulated me to challenge the effectiveness of the engagement and consultation process currently being employed in the production of the Abbots Bromley Parish Neighbourhood Plan.

More recently I have conducted a 3 week Independent Straw Poll of parishioners views in relation to their feelings regarding **effective engagement and consultation** for three distinct stages:

- The production of an Abbots Bromley Parish Neighbourhood Development Plan.
- The proposed site/sites selected for future development.
- The proposed number and types of property to be built.

Initially, I set about the daunting task of door to door canvassing for community opinion.

I was quickly supported by residents who took responsibility for their own neighbourhood.

Identical forms were also available at a number of popular village outlets and were publicised as such via the social media platform 'Spotted Abbots Bromley' (which I understand has a considerable following?).

At all times residents were informed that the questionnaire was available at their liberty to complete and return. Simple indication of either YES or NO was requested to the specific questions which indicated a clear purpose.

I have been quite amazed by the interest that this initiative has generated. To date I have received completed forms representing the 'free' opinion of **386** bona fide residents of the Parish.

There were 3 additional forms received (one from an underage resident and two from outside of the Parish ..... these have not been included in the results).

I wish to share with you the fully anonymised results of the questionnaire, in order that it may help shape a successful outcome for the Abbots Bromley Parish Neighbourhood Plan.

In question order:-

Q1. Have you been fully engaged and consulted in relation to the production of the Abbots Bromley Parish Neighbourhood Development Plan.

From **386** responses

**YES .... 18** some with amplifying comments indicating the engagement level that those respondents considered appropriate to their answer.

**NO .... 366**

There were **2** responders who answered between the two options which I have rightly included in the total.

Q2. Have you been fully engaged and consulted in relation to a proposal for development of land off Radmore Lane and off Schoolhouse Lane.

From **386** responses

**YES .... 4**

**NO .... 381**

There was **1** responder who answered between the two options which I have rightly included in the total.

Q3. Have you been fully engaged and consulted in relation to the proposed number/types of property to be developed on land off Radmore Lane and off Schoolhouse Lane.

From **386** responses

**YES .... 2** one with amplifying comments provided; and another with a full narrative attached.

## **NO .... 383**

There was 1 responder who answered between the two options which I have rightly included in the total.

**23<sup>rd</sup> May 2018**

- Member of the public asks if Cllr Walters can answer the question as to how they got down from 8 sites to 2 sites. Cllr Walters confirmed that the sites were assessed and scored and 2 sites came out higher. This was the view of the group and we compiled a report. We have tried to forward our view as a group, quite open to the fact that it is our view.
- Member of the public said that the question is, are you going to go back and revisit the site selection? Surely you are going to take it on board and go back a stage. Cllr Walters said that it is up to the Parish Council to make the decision as they are the designated body. Member of the public said that it is clear that people are not happy. Cllr Walters said that he has heard what everyone has said. Cllr Walters said that he has done it in the best way he could.
- What criteria was used to access the sites, is that available on the website? Cllr Walters confirmed that the information is available on the website.
- Member of public asked where the second site is. Cllr Walters confirmed that the second site that was chosen was on the end of Bagots View.
- Member of the public asked how many people attend the site selection meeting at Church House, Mr Wheeldon confirmed that 12 members of public attended this event.
- Member of the public said that on 23 Feb 2015 a survey was done on School House Lane. On that day 880 vehicles used that lane and 628 pedestrians walked up and down. Information on that survey was sent to the Neighbourhood Planning Group.
- Resident from Radmore Lane commented that there are possible developments at Site No 2 and Site No 3, to the side and front of his house. On the plan he had seen there is a retirement home and also a drop off point for coaches. The school seems to be adding more to their site plan. If the school are going to pursue a major development then Radmore Lane is going to have to carry a considerable amount of traffic. He was present at the meeting in March 17 and no sign from the school of the new road they had mentioned at that meeting that would be opposite Ivy House. Cllr Walters confirmed that he had received a letter from the resident with his concerns. Cllr Walters said that we haven't got to the stage of a plan from the school that the Neighbourhood Group are happy with. Member of the public said that he reiterates comments earlier that it is a thankless task and appreciates the work that has been done so far.
- A member of the public asked if Cllr Walters offered planning advice to the school. Cllr Walters said that the school has its own planning advisers so I don't offer them planning advice.
- Member of the public suggested that Mr Wheeldon goes back on to the Neighbourhood Planning Group so that residents know that there is someone on the committee that they

have confidence in and can trust that the process is being handled properly. He said that he had only seen one lot of drawings for the one site and asked if there were any plans for the other 7 sites. Does that mean that there aren't any or that they have been ignored? He suggested that these are the sort of things that should be relooked at.

- Cllr Walters confirmed that the group have only looked at how the sites they have selected can be developed and not at the other sites.
- Member of the public suggested that if it is a flawed choice then it is no choice. How do we move forward? What assurance can be given that what has been said tonight will be considered? Is it just down to the Parish Council?
- Cllr Walters said that what happens next is that the Parish Council is the designated body and they can change us, dissolve us, do it themselves. Member of the public said that what we need to understand is how the Parish Council is going to take on these comments, if it's not in your domain. Cllr Walters said that he would pass this over to the Chair. Mr Wheeldon asked if the Chair could also answer his question about what he was going to do with the statics he had provided.
- Cllr Charles says that the PC will most likely look at the process again. Cllr Moore said that it needs to be voted on at the next PC meeting. All thoughts will be taken on board and then voted on. Cllr Walters said that we need go away and consider this. Parish Council meets next Wednesday and you are more than welcome to attend this meeting. and decisions will be in minutes.
- A member of the public asked where the details are of all the other sites. Cllr Walters confirmed that these are on the noticeboard by the Buttercross. A member of the public asked if these included the SHLAA sites as well. Cllr Walters confirmed this.
- Member of the public asked if there had been a count up of the number of houses on the school site. The number of 30 was mentioned.
- A member of the public said that everyone is here because they are concerned. When this is discussed what is going to be the feedback to us. Cllr Walters said it will be discussed at the next meeting and decisions will be made at the meeting. This will be reported in the minutes. The member of the public said that only part of the meeting is open to the public. Cllr Walters confirmed that members of the public can only speak in the public session but they can attend the whole meeting. There will also be something in the Bulletin.
- A member of the public said that communication needs to be a two way street, need to put people more in the picture and presenting it in a way that clearly informs people.
- Resident from Bagots View said that they would be directly affected and there would considerable objections to any development here for a number of reasons including motivation, implications on traffic and also things have been said that are incorrect about the views of the residents of Bagots View.
- Member of the public said that the minutes seem to be very tardy in when they are put on the website. The Clerk said that they normally go up about two weeks after. This was challenged by a member of the public and said that they were not up after January and the Parish Assembly minutes won't be available until the next year. The Clerk said that Parish Council minutes have to be posted with the agenda before the next meeting so they are always available on line as a draft.
- Member of the public asked if a traffic survey been done has been done on Radmore Lane and the main street. Cllr Walters said that when we get to the consultation stage we will bring in Staffordshire County Council Highways to do this work.
- Member of the public says she knows how much work has gone in to the neighbourhood plan, however, School House Lane very busy with cars and tractors, road surface very

poor. Traffic has increased considerably. Becoming dangerous for people to walk up and down that road.

- Resident asks if we need to put a number of houses in the neighbourhood plan. Cllr Walters said that we don't have to put in the number of houses, we can allocate sites and people can comment on this. The group have tried to identify how these sites can be used.
- Resident asks what chance we would have for getting the neighbourhood plan through. Cllr Walters said that based on people in the room then it is probably no.

The Chair asked if there were any further comments. With no further comments he thanked everyone for coming.

- 1) So one of the main comments was that the community welcomed progress made with the plan but were concerned about a number of key issues

- Housing needs assessment report of the consultation  
The data and the findings of the housing needs survey
- Results and report of the site selection process  
The methodology used to assess sites and the full results of the assessment of all of the sites
- An assessment of the local landscape character & built environment  
A piece of work carried out by the group to look at and identify important features of the local environment

We've asked East Staffordshire BC to review the documents for us but all will be available on the website in full shortly.

- 2) Notwithstanding the point about the evidence base people also had concerns about

- Radmore Lane junction, footpath provision, restricted access  
We've asked Abbots Bromley School to look in detail at these matters as "in principal" issues. What that means is that we won't consider a detailed scheme or other matters related to the potential development until such issues have been explored with the Highways Authority.

This therefore means that if acceptable solutions cannot be found then they are deal breakers to the overall acceptability of the site.

The school have indicated to us that they have a consultant looking at this and that we should get some information in due course
