128.3 Miscellaneous financial matters

- **Payment of Clerk's gratuity** - The clerk reported that the gratuity to Mr Roy had to be paid net of tax and NI as two years ago the opportunity to register the gratuity scheme had not been taken. At the time the SPCA had not notified councils of the need to register such schemes. A number of parish councils in Staffordshire have found themselves in the same situation.
- **Accounts software** – the clerk reported that she had had to make a technical call to Intuit to resolve the problems with the software. The cost had been £35.00 for a one off call, the other option had been for a years unlimited help1-4 at a cost of £149.99.

Minute 129: Group Reports

129.1 Recreation

The clerk reported that the paint had now been collected for the Millennium Green and the work would be undertaken as soon as the weather allows.

Cllr Coxon reported that the under 5's playground is locked at dark, but the notice does not reflect this

RESOLVED: Cllr Coxon will renew the notice of opening times at the Nuttery

A report on the meeting which had taken place on 18th March, 2008 was given. The notes taken by Cllr Mrs Veitch were circulated. Mark Koszak from Staffordshire Council for Voluntary Youth Services (SCVYS) had attended along with a good number of young people and some adults.

The meeting was intended to be the discussion forum, with the ideas and work being done by the young people. The young people had indicated that basically they wanted somewhere to meet, possibly a shelter, but Mr Koszak had pointed out that there could be problems with siting and lack of supervision, and suggested a Youth Club may be better. If the Youth Club route is pursued, SCVYS can offer help with peripatetic staff, training, insurance, and CRB checks initially, but the adults to run the club would have to be provided locally.

The Crown has been approached about their room, but it is not deemed suitable.

Cllr Coxon has drafted a newsletter and Mrs Copland and some of the young people are working on a newsletter. Mrs Turvey has agreed to attend a training course on running a Youth Club.

Overall the meeting was well attended and was very successful with a good atmosphere.

A number of young people have places at Burton College, but there is no public transport available. It was noted that it is very sad that young people who want to attend college but can't due to lack of travel provision. Mark Koszak had agreed to investigate the Youth Forum in Uttoxeter and Burton on Trent to see if it is possible to lobby for a bus service. It was noted that the Girl's School must run a day bus from Burton to Abbots Bromley, could this present any opportunities for co-operation in transport provision?

RESOLVED: that the clerk would speak to SCC re: the provision of a bus service from Abbots Bromley to Burton to cater for college students.

Where could a shelter be sited? – the Millennium Green was a possibility, but it would need to be ascertained if this were possible. A basic shelter could start at £5,000, but £10,000 is really required for a decent shelter. Mayfield Youth Shelter cost around £1,000, but this was a self build. Any shelter would have to be well lit and in a public place.

Simon Tonking expressed an interest in helping with a self build project.

It is known that in Penkridge, the Church has open doors on Friday evenings for Young People and hot chocolate and biscuits are served. The clerk reported that similar scheme had operated in Yoxall too.

RESOLVED: that a further meeting be held in April

RESOLVED: that the clerk enquire about the need for planning permission for the erection of a youth shelter.

There have been some problems with young people and the Nuttery Play Area, but the only damage done has been to bend the bin lid. During the last week a group of 3 lads had been hanging around the Nuttery and had refused to move. It is felt this is rather intimidating for the young children and that if it reoccurs the police should be called. It was noted that great care should be taken when speaking to young people in these situations so as not to compromise personal safety.

129.2 Village Property

The bench by the bus stop opposite the top shop is being used as a congregation point and there has been a request that this be removed. In addition litter round the village is a problem.

RESOLVED: that no further action be taken at present until the outcome of the youth project is known.

129.3 Traffic, Parking, Highways

Four companies have responded to the letter sent to all local haulage companies.

Letters have been sent to both SCC and ESBC regarding roads included on sat nav systems. ESBC had contacted the clerk to say that this was a matter for the county council.

Site Meeting – this had been attended by Cllrs Charles, Jarman and Waring and the clerk with Richard Rayson from SCC to discuss a number of issues.

- **Re-siting the 30 mph restriction on Goose Lane** – siting of the new signs had now been agreed on both Goose Lane and Yeatsall Lane, and this will include the nursery entrance. Cllrs Charles and Jarman would be discussing this with the landowners involved.
- **Graffiti on pavements** – Goose Lane, Friary Avenue and surrounds – Mr Rayson has promised to get the contractors to come back and paint over the red and other coloured marks. Anti-graffiti paint is not an option on tarmac as it dissolves it.
- **Man holes on Ashbrook Lane** – Mr Rayson will make arrangements to get these surveyed and any work required will necessitate the closure of Ashbrook Lane
- **Weight limit** – the possibility of a weight limit in the village was discussed, but B roads are identified as suitable roads for HCV traffic. At present SCC are carrying out a review of the grading of roads within the county.
- **Speed limit in the village** – the question of introducing a 20 mph restriction in the village was discussed, but this is unlikely to be achievable, as it would have to be part of a county wide policy. E.g outside all schools, and there are places where this would simply not be viable
- **Illuminated speed signs** – a resident has offered to organise fund raising towards the installation of such signs. Mr Rayson explained that input of a financial contribution did not automatically move a location up the list. If the area is not assessed as needing such signs, they are not provided. At present all villages in the county are being assessed.

Mr Rayson has agreed to assess Abbots Bromley by means of three temporary signs at the village entrances. For the first week the signs are not switched on and then they are operational. Often with signs at the village entrances it slows traffic down but then it speeds up in the village centre again. The county council policy is that there must be a major problem before any action is taken.

- **Lichfield Road footpaths** are due to be resurfaced during the financial year starting on 1st April 2008

- **Goose Lane** – Butt Cottage to Barn – the ditch has been completed filled in due to over-running by heavy vehicles
RESOLVED: the clerk will report this matter to CLARENCE
- Goats Head parking – concern was expressed regarding the danger caused by cars parking on the road around the corner by the Goats Head
RESOLVED: the clerk will speak to SCC re: the safety of this parking practice and the manager of the pub to ask if signage could be considered in the windows of the pub asking customers to park responsibly
- **Lichfield Road gulley work** – the barriers appear unsightly, this is because they have to meet with EEC rules. This was noted but it falls outside Abbots Bromley

Cllr Mrs Fox briefly outlined what the RISES scheme was and who the members of the committee were – herself, the manager of the Crown, Michelle Moore and Jill Crook. The money is held by the parish council for the committee to decide how to spend. Suggested projects being looked at are equipment for the junior football and cricket teams or gravel around the recycling bins, but it is brewery land and they could be insurance problems.
