ii. Visit by Mr P Somerfield, ESBC

Mr Somerfield listened to the concerns of the parish council regarding the lack of consideration by the planning department to issues and objections raised by the parish council. The parish council also raised the issue that the electronic system does not work properly and delays are always encountered when trying to access supporting documents.

Mr Somerfield updated the parish council on the restructuring that is currently taking place within the planning department which he believes should help to improve communication with parish councils and improve enforcement after planning consent has been given. He also highlighted that a development plan was currently being considered for Blithfield Reservoir. Mr Somerfield also confirmed that he would investigate the issue regarding the on-line planning system.

100. Group Reports

i. Recreation

Football Pitches

Cllr Mrs Veitch reported on the work that needs to be carried out to the football pitch including re-seeding and the possible installation of artificial turf in front of the goal posts. The dugout also needs to be resited following the recent wind damage. Cllr Veitch asked that the parish council consider funding the resiting of the dugout up to a cost of £580 and to part fund the artificial turf up to £1,500 which could be taken from the Recreational Fund.

RESOLVED: That the Clerk would obtain additional quotations for the work to be carried out and that work could commence when sufficient quotes had been sourced. Total budgets to not exceed £580 to cover the dugout and £1,500 for the football pitch. Proposed Cllr P Charles, seconded Cllr Mrs L Fox.

Youth Club:

Cllr Mrs Veitch and The Clerk reported that the club was still very well attended with 26 at this week's club. The Clerk gave a full report on the recent activities that had been undertaken by the club and the proposed forthcoming trips. She also highlighted the efforts that the club had made to raise their own funding.

ii. Village Property

The Clerk reported that the Nuttery safety inspection had recently taken place and that no immediate action was required. The inspection also covered the slide on the Millennium Green and the inspection did highlight that some work around the slide and to the paintwork was required. The Clerk also reported that she was currently sourcing quotes to undertake the painting work at the Nuttery and that this would also include the slide at the Millennium Green.

The weekly inspection of the playgrounds no longer takes place.

RESOLVED: that the Clerk should contact the insurance company to ascertain if a weekly inspection is necessary.
