20. Public session

i. Village Mini Bus

Cllr R Jarman and the Clerk presented the plans for the Village Mini Bus. They explained that the Scouts had been given three options regarding the purchase of the bus. These being:-

- a. The mini bus would be purchased by the Parish Council and then would remain an asset to the PC so that the VAT can be claimed back. If this was the case then a strict booking policy would need to be in place which would have to be approved by the PC
- b. The mini bus would be purchased by the Parish Council and the ownership would be passed directly to the Scout Group. If this option is chosen then the Scout Group would need to raise the additional funds to cover the VAT.
- c. The mini bus would be purchased by the Parish Council and the ownership would be passed directly to the Scout Group. The Scout Group would need to cover the cost of the VAT but the Parish Council would consider offering a donation of £1,000 towards this.

It was reported that the Scout Group had still to come back on which option was preferred. Cllr R Jarman asked if there were any objections to the three options. There were no objections.
