
WHEREAS The East Staffordshire Borough Council (hereinafter referred to as "the Council") being satisfied that traffic on Bagots Street/High Street, Abbots Bromley should be prohibited in connection with the Abbots Bromley Horn Dance on Monday 9th September 2013.

NOW THEREFORE, the Council in exercise of their powers under Section 21 of the Town Police Clauses Act 1847, hereby make the following Order:

1. No person shall cause any vehicle to proceed along Bagots Street/High Street from its junction with Harley Lane to its junction with Radmore Lane on Monday 9th September 2013 between the hours of 8.00am to 9.00am and 3.00pm to 8.00pm.
2. The alternative route for vehicles affected will be:

Via Harley Lane, Schoolhouse Lane and Radmore Lane
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
4. This Order shall be cited as The East Staffordshire Borough Council (Bagots Street/High Street, Abbots Bromley) (Temporary Closure to Traffic) Order (No.2) 2013.
